Release eo2025.09.01 Summary:

Release eo2025.09.01 is scheduled to be deployed beginning at 6:00 p.m. ET on Monday, August 4, 2025.

This release includes an update to e-OSCAR's Archive features as described below:

I. ENHANCEMENT OF ARCHIVE CAPABILITY TO ALLOW MULTIPLE ARCHIVE REQUESTS PER CASE TYPE

Historically, Data Furnishers have been able to schedule either a reoccurring Archive or an ad hoc Archive for transactions in e-OSCAR, but limitations allowed only one type of Archive request to be scheduled per transaction. For example, if a company had a weekly reoccurring Archive scheduled for ACDVs, there was no way for that company to additionally request an additional reoccurring Archive or an ad hoc Archive for ACDV transactions without overwriting the existing scheduled request.

This release adds a long-awaited feature that will allow companies to schedule multiple Archive requests for the following transaction types in e-OSCAR: ACDV, AUD, Block Rescission Request (BRR), Block Notifications, Dispute Response (DR) Notifications, and AUD Notifications.

Specifically, the following changes will apply:

- Operators can schedule multiple ad hoc or reoccurring Archive requests for each e-OSCAR transaction. These additional requests will not overwrite any existing Archive requests
- Operators can schedule one of each reoccurring Archive schedule type (daily, weekly, and monthly) for each e-OSCAR transaction
- Additionally, up to three (3) ad hoc Archive requests can be scheduled daily
- All scheduled Archive requests will be displayed on the Archive Schedule page, with ad hoc Archive requests listed at the top of a list and reoccurring Archive requests listed below
- All Archive requests will include the following schedule details: (a) Report Status (new, deleted, retry, successful), Deleted By, and Deleted Date. If a request has not been deleted, values in the Deleted By and Deleted Date columns will be null. Successful ad hoc Archive files will be available for up to two weeks
- Operators can be added to the automatic email notifications when Archives are available following the scheduling of an Archive request
