**Legal Requirements:** We may disclose your information if required by law or in response to valid legal requests, such as court orders or subpoenas.

**Business Transfers:** If our company is involved in a merger, acquisition, or sale of assets, your email information may be transferred as part of that transaction. We will notify you of any such change.
