### Release eo2024.04 Summary

Release eo2024.04 is scheduled to be deployed beginning at 6:00 p.m. ET on Thursday, March 21, 2024. This release addresses several technical defects reported by end users of the e-OSCAR platform and applies slight modifications to certain features in e-OSCAR.

#### I. BLOCK NOTIFICATIONS CASES WITH AFFIRM – LINKED CASES:

Corrects a situation where cancelling an "affirm" action on Block Notifications prevented the selection of "acknowledge" action and instead submits the "affirm" action on linked cases.

#### II. OPERATOR MANAGEMENT RESTRICTED PERMISSION:

Corrects an issue that prevented Operator Administrators (OA) with restricted permissions from seeing a full list of operators for the Registration in situations where the OA has no "Reports to".

#### III. DATE OF BIRTH FIELD UPDATING INCORRECTLY:

Corrects an issue causing in the Date of Birth to update when Operators are using the Cut / Paste capability to update consumer address information on the Consumer Information Page.

#### IV. AUTO ASSIGN FUNCTIONALITY:

Corrects an error that prevented the auto assign function from correctly assigning ACDVs to correct Operators.

#### V. OPERATOR MANAGEMENT UPDATES:

Updates capabilities to prevent Registration Administrators (RA) and Operations Administrators (OA) from inadvertently updating their own profiles in such a way that would limit or negatively impact their overall capabilities, but does allow the Registration Administrator of Record (RAoR) to update their own profiles.

#### VI. ELIMINATION OF DEACTIVATED OPERATORS FROM LISTS:

Updated report notification selection lists to remove any deactivated operators, eliminating the possibility for these operators from being included on scheduled reports.

#### VII. REPORTS VIEWER ROLE NOT RETURNING ACTIVITY REPORT RESULTS:

We have corrected an issue that is causing operators with only Reports Viewer access from receiving proper results when running an ad hoc Activity Report.

#### VIII.REPORT CARD / ACTIVITY REPORT ACDV ALIGNMENT:

We have fixed an issue where the inputs for a Report Card did not match inputs for an Activity Report.

#### IX. OPERATOR MANAGEMENT FOR OPERATORS WITH SKILLS:

We have corrected an issue preventing the deletion of Operators by selecting the "check box" under the Operators with Selected Skills modal window.

#### X. API-SERVICES: ERROR CODE 4100:

We have updated the error logic for AUD and BRR Submissions to trigger when the value of the Company ID does not match the RegID value of the logged-in API User.
